AGREEMENT

on mutual rights and obligations for the doctoral program **EVIDENCE-BASED MEDICINE**

Article 1

This agreement regulates mutual rights and obligations between the School and the Student for obtaining the doctoral degree.

Article 2

The parties agree that the Student is enrolled in the university postgraduate doctoral program EVIDENCE-BASED MEDICINE (hereinafter: the Program) in the academic year 2016/2017. The Program lasts six semesters.

The classes begin on ______.

Article 3

The tuition fee for each academic year of the Program is 20,000.00 HRK (in letters: twenty thousand Croatian kunas).

The tuition covers the cost of organization and delivery of courses and costs of dissertation proposal, evaluation, and defense.

The tuition fees for the second and third year of the Program are the same as the tuition fee specified in section 1 of this Article if the Student enrolls in the second year not later than______ and in the third year not later than______. In case that the Student enrolls in the second or third year of the studies after the time specified in section 3 of this Article, the Student covers the tuition fee according to the tuition rates valid at the time of enrollment.

If the Student decides to withdraw from the Program after already enrolling in one of the academic years, the student is not entitled to tuition fee refund.

The Student shall pay the tuition fee for the first semester of the first year of the Program at the time of enrolment, to the School's bank account number: **HR8523300031100071293**, reference number **603**.

The Student shall pay the tuition fee for the second semester by the end of the academic year in which he/she is enrolled.

Article 4

The Program classes may be delivered in Croatian or English language. In case of a justified reason for interruption of the studies, the Student may request that the Student's rights and obligations be temporarily suspended during the break.

Article 5

The Student shall earn the prescribed number of credits from each credit group according to the teaching plan and program for the current academic year.

Article 6

By defending the doctoral dissertation, the Student agrees to the requirement that the dissertation be made publicly available at the School's website.

In exceptional cases, online publication of the dissertation may be postponed for not longer than one year.

If the Student fails to complete the prescribed obligations on regular basis, the provisions of the Regulations on the Study and Studying System in professional and integrated studies at the School of Medicine in Split apply, as well as other enactments arranging the studying requirements and coverage of study expenses applicable at the point of submission of the request.

Article 8

In case of issues not explicitly listed in this Agreement, the provisions of the valid Regulations on University Postgraduate Studies and Doctoral Graduation Process apply.

Article 9

This Agreement is deemed terminated if the Student fails to complete the obligations defined by this Agreement and the Program enrolled.

Article 10

Rights and obligations from this Agreement are valid from the day of its closure. This agreement is drafted in two identical copies, one for each party.
