Pursuant to Article 43 of the Statute of the School of Medicine in Split, after consultation at the special session of the Dean's Board held on 12th March 2020, in relation to the implementation of measures for combating the spread of coronavirus, the Dean made the following

DECISION

- Due to the increasingly serious epidemiological situation regarding COVID-19, all activities which are not related to teaching are postponed (<u>https://www.hzjz.hr/priopcenja-mediji/koronavirus-najnoviji-podatci/</u>)
- 2. All employees who have travelled outside Croatia anytime in the past 14 days are obliged to report to the School Management and remain in self-isolation during which time they will work from home (14 days in total from the date of return to Croatia). In case they develop any symptoms during self-isolation, they should report to the epidemiologist in charge according to the CIPH instructions (https://www.hzjz.hr/aktualnosti/brojevi-telefona-hzjz-na-temu-koronavirusa/)
- 3. **All students** who have travelled outside Croatia anytime in the past 14 days are obliged to report to the Vice Dean for Teaching and remain in self-isolation (14 days from the date of return to Croatia). In case they develop any symptoms during self-isolation, they should report to the epidemiologist in charge according to the CIPH instructions

- 4. Heads of Departments and Heads of Administration must keep the School Management informed on a daily basis and submit the list of employees who are in self-isolation at povjerenstvo_korona@mefst.hr
- 5. **Heads of Departments** must keep the Vice-Dean for Teaching informed on a daily basis and submit the list of students who are in self-isolation at <u>povjerenstvo_korona@mefst.hr</u>
- 6. Absence from classes will be excused by Dean's special decisions.
- 7. Employees and students suffering from chronic illnesses, and pregnant women are advised to stay at home for 14 days and work from home. They must inform the School Management or Vice Dean for Teaching.

- 8. Clinical classes in which the student is in direct contact with the patient are postponed for 14 days from the date of this decision.
- 9. Teaching in postgraduate university studies (doctoral studies) is postponed for 30 days from the date of this decision
- 10. Communication with all student offices will take place only electronically from the date of this decision
- 11. **Teachers** are obliged to prepare all lectures and seminars that can be carried out online for 2 - 3 weeks of teaching, as a preparatory action if a decision is made by the National Department of Civil Protection to close the higher education institutions.
